GENERAL TERMS OF SALE

1. **General information:** except for special sales conditions, justified by the specificities of the products and services provided, any order sent to FRUTEATE, S.L. (telephone, Whatsapp, email) implies the unconditional acceptance of these general conditions, which cannot be modified even by contrary stipulations that may appear in the customer's order forms or in their general conditions of purchase.
2. **Price:** unless specially provided in the sale, our prices are understood according to Incoterm 2020 CPT. Administrative fees of €2.90 as well as €1.90 for pallet exit are applied per order, regardless of the number of pallets ordered.
3. **Products quality:** sales made without a specific stipulation on quality are always understood as healthy, loyal and marketable merchandise, in accordance with European and national quality standards when they exist for the agreed category. To be admissible, any reserves relating to damage suffered during transport or missing items must be made by the customer or his representative, at the time of delivery, in writing on the delivery document. Any claim about the intrinsic quality of the merchandise must be sent to FRUTEATE, S.L. within a maximum period of 24 hours from receipt of the merchandise. As the goods are subject to desiccation, the departure weight alone is valid. Compensation for loss of commercial qualities of a product can only be made after the return of the defective product, within a period less than or equal to 3 working days.
4. **Transport and insurance:** notwithstanding any retention of title clause, the risks related to the goods are transferred to the buyer at the latest at the time of delivery. Shipments are insured by FRUTEATE, S.L. against any loss or damage to the recipient's interest. The insurance extends to the customer's domicile and does not include any handling within the customer's premises.
5. **Payment terms:** the payment period is 30 days from the date of invoice. In case of insufficient solvency, or denial of commercial credit by our insurance, or first order from our client, we may request payment in advance. In case of non-payment on the due date, the customer will exclusively assume all the economic, fiscal, civil and criminal consequences. Any dispute related to the sale will be, in case an amicable solution cannot be found, be subject to Spanish law under the jurisdiction of the Commercial Court of Vinaròs-Castellón (Spain).
